The research employs qualitative methods, including syntactic analysis and stylistic evaluation, to investigate sentence structures, grammatical deviations, and punctuation usage across both genres. The findings reveal that academic writing typically employs complex, rule-bound grammatical constructions to establish authority and coherence, whereas creative writing leverages grammar as a fluid, expressive device that supports aesthetic and rhetorical aims. Notably, what is considered a grammatical error in academic contexts may be an intentional and meaningful stylistic choice in creative ones.

This paper contributes to both linguistic and pedagogical discussions by illuminating the dual role of grammar—as a system of rules and a tool for artistic license. It argues that understanding this duality is essential for writers, educators, and students alike. Bridging the divide between prescriptive and descriptive grammar, the study encourages a more flexible and genre-sensitive approach to teaching and evaluating writing.

While grammatical deviations in academic writing often result in diminished clarity or perceived incompetence, such deviations in creative writing can enrich narrative depth. For instance, non-standard grammar in dialogues enhances authenticity, especially in regional or culturally specific settings.

Academic writing often employs passive constructions to maintain objectivity ("The experiment was conducted..."), whereas creative writing favors active voice to engage the

reader and create immediacy ("She ran through the storm..."). This grammatical choice directly affects tone and agency.
